Ingurane yo kw'ikori ry'agataka rya Vermont irafasha abanya Vermont benshi bafise amazu mu kuriha amakori yo ku mazu yabo. Urashobora kwemererwa kuronka ingurane ryo ku makori y'agataka ku makori yo ku matungo yawe nimba amatungo yawe akwije ibisabwa nk'inzu kandi ukaba ukwije ivyangombwa bisabwa. ingurane ntarengwa ni \$ 5,600 ku gice c'amakori yamatungo ya Leta y'indero na 2,400 \$ ku gice cy'amakori ku gice camatungo ya komine.

Kwemererwa

Kugirango usabe ingurane yo kw'ikori ry'agataka, utegerezwa kwuzuza ivyangombwa VYOSE vyo kwemererwa bisabwa bikurikira:

Itariki ntarengwa yo gusaba ingurane yo kw'ikori ry'agataka ni nayo tariki itegekanijwe yo kumenyekanisha amakori muri Vermont hamwe n'itangazo ryo kumenyekanisha inzu n'ikibanza irimwo, mu bisanzwe ikaba ari 15 Ndamukiza. Mu gihe umenyekanishije inzu yawe imbere y'igihe c'inyongera co kw'itariki ya 15 Gitugutu, urashobora gusaba ingurane yo kw'ikori ry'agataka bitarenze kw'itariki ya 31 Ntwarante y'umwaka ukurikira. Arikoo, amafaranga \$150 y'igikorwa azokurwa ku ngurane yawe yo kw'ikori ry'agataka. Inyuma y'itariki ya 15 Gitugutu, ingurane yose yo kw'ikori ry'agataka izorungikwa kwa nyen'inzu atari ku gisagara.
