

State-Sponsored Courses for Listers and Assessors at No Charge to Municipalities

The Division of Property Valuation and Review (PVR) offers lister and assessor courses at *no charge* to current Vermont municipal assessment officials.

PVR partners with organizations such as the Vermont Assessors and Listers Association (VALA), the Vermont League of Cities and Towns (VLCT), and the New England Municipal Resource Center

(NEMRC) to directly sponsor events and to eliminate and reduce training charges for listers and assessors. This includes VALA trainings, VLCT workshops, and the International Association of Assessing Officers (IAAO) courses and workshops.

All the courses listed here are free to municipalities.
